

## US\$140 million follow-on equity investment into ESR by Stepstone and SSGA

Shanghai/Hong Kong/Singapore/Tokyo, November, 2017 – ESR Cayman Limited ("ESR"), the leading pan-Asia logistics real estate developer and operator, announced that the group has closed a US\$140 million equity investment by a client of State Street Global Advisors ("SSGA") and various Stepstone funds ("Stepstone", together with SSGA, the "New Investors").
